### **MINUTES**

#### I. <u>Call to Order</u>

The Regular Meeting of the Board of Trustees of Raritan Valley Community College was held on Tuesday, April 30, 2024, in-person and via Zoom Webinar. Chair Zenon Christodoulou called the Regular Board of Trustees meeting to order at 4:20 p.m., and made the following statement in compliance with the Open Public Meetings Act of the State of New Jersey:

### III. Agenda Items

1. Approval of Meeting Minutes

The Regular meeting minutes of March 26, 2024 were moved by Trustee Helena Swanike, seconded by Trustee Roger Jinks, and approved by voice vote.

2. President/Chair Reports

President McDonough reported that Commencement will take place on Saturday, May 11, 2024 at 10:00 a.m. noting that two-time Super Bowl Champion, former New York Giant Kareem McKenzie will be the keynote speaker. President McDonough reiterated that attending Commencement is a wonderful way to celebrate the hard work of RVCC students and faculty.

President McDonough thanked Hunterdon and Somerset counties for their support in making Raritan Valley Community College an affordable option for students.

Chair Zenon Christodoulou recognized everyone celebrating Orthodox Easter this coming Sunday. Chair Christodoulou also agreed that Raritan Valley Community College is a more attractive option over colleges like Yale University which has surpassed six figures per year.

### 3. Committee Reports

## A. Strategy and Vision Committee

It was reported that the Committee met earlier in the day where Provost Karen Bearce introduced an informative presentation by Diane Walleser and Mary DeLuca from Interact Communications. Interact's engagement with RVCC will help the College assess how well our marketing and enrollment strategies are aligned to our current market and student needs. The timing of the College's engagement with Interact connects nicely with the work we are doing relative to our new strategic plan.

## B. Audit Committee

Trustee Thomas Borkowski gave a brief overview of presentations given by the two audit firms that submitted proposals to become the college's next audit firm. On a motion by Trustee Caren Bateman and seconded by Chair Christodoulou, Resolution #131-FY24 was approved by voice vote. The resolution states that Supplee, Clooney & Company will be the College's audit firm for FY 2024 and FY 2025.

WHEREAS, the County College Contracts Law permits the Board of Trustees to award a contract for professional services without advertising for bids, pursuant to N.J.S.A. 18A-25.5a(1);

NOW, THEREFORE, BE IT RESOLVED, that it is the recommendation of the Audit Committee that:

Thomas Borkowski, Chairperson of the Audit Committee of the Board of Trustees of Raritan Valley Community College, is hereby authorized to retain the services of Suplee, Clooney and
